4a (Code: ) (Expenses \$ 686,395. including grants of \$ ) (Revenue \$ ) VETERANS BRIDGE HOME SERVES AS THE BACKBONE ORGANIZATION FOR NCSERVES MARKETS: CHARLOTTE, TRIAD, TRIANGLE AND FAYETTEVILLE AS A COORDINATED CARE NETWORK CONNECTING SERVICE MEMBERS, VETERANS, AND MILITARY FAMILIES TO SERVICES THROUGH A COLLECTIVE IMPACT MODEL TO IMPROVE SOCIAL DETERMINANTS OF HEALTH. IN 2020, VETERANS BRIDGE HOME CONNECTED 2,430 VETERAN SERVICE MEMBER FAMILIES, A 32% INCREASE, TO 5,632 SERVICES, AN AVERAGE OF 2.3 SERVICES PER FAMILY. THE TOP 3 NEEDS WERE: HOUSING, EMPLOYMENT AND SOCIAL ENRICHMENT WITH THESE CATEGORIES MAKING UP 57% OF ALL NETWORK REQUESTS. IN 2020 THE NETWORK RESOLVED 85% OF ALL REQUESTS FAVORABLY. VETERANS BRIDGE HOME CONNECTED 280 VETERANS AND 97 EMPLOYERS THROUGH 6 HIRING EVENTS, WHICH INCLUDED DIGITAL MATCHING. WE ALSO LEAD 10 VETERAN HIRING TRAININGS WITH 517 EMPLOYER ATTENDEES.

WE HAVE OVER 5,000 VETERANS IN THE CHARLOTTE MARKET ALONE. WHILE THE COVID-19 PANDEMIC GREATLY IMPACTED OUR SOCIAL ENRICHMENT EFFORTS IN THE COMMUNITY, WE WERE ABLE TO SHIFT FROM PRIMARILY IN-PERSON TO 168 VIRTUAL AND SOCIALLY DISTANCED EVENTS.
